


MAVEN Release Notes – J Release

Global MAVEN Changes

- 1) Update *Does case have multiple employers?* Question Block in the Demographic Question Package Add free text Occupation and Industry and Turn on API & Retire existing reference list for Occupation.
- 2) Update existing concern (concern shows up for certain diseases once the question is answered the red flag will stop showing) for Foodborne/Waterborne disease events to complete Industry & Occupation.



3) Create three new variables in Official City block (Latitude, Longitude, Census Tract).

Healthcare Acquired Infections (HAI)

- 1) Update Invasive Group A Strep events' immediate notification emails to be sent only for Confirmed Events
- 2) Automate more reports for GAS Dashboard.
- 3) Add "What specimen triggered investigation?" to Healthcare Acquired Infection cluster events.
- 4) Update to IP Wizard for Candida auris and Multi-Drug Resistance Organisms.
- 5) Remove '(I.e. survey staff)' from on-site component message in EPI/IMM Cluster Admin Question Package.
- 6) Retire & Replace "Name of Facility" Question in "Epi-linked" question package for HAI events.
- 7) Update 'Multi-Drug Resistance Organisms (MDRO) Lab work Needs Review Antibiotic Resistance' WF to include CLOSED events.

1) Create a workflow for closing COVID and ILI clusters.

Foodborne & Waterborne


- 1) Create Invasive Cronobacter Product Code and Update other Backend Criteria.
- 2) Invasive Cronobacter Reports Updates.
- 3) Edit Foodborne Cluster/Outbreak Linelist Report.
- 4) Add reference codes to reference group CLINICAL_COMPLICATION_OPTIONS.
- 5) Add new column (National Cluster ID) to Enteric Sequencing Needs Review workflow table.
- 6) Update condition for SEXUAL PARTNERS question in SHIG events and add for all enteric pathogens.
- 7) Update Enteric CRF Review wizard with new variables.
- 8) Retire ANY OTHERS SHARE EXPOSURE question from Giardia and Calicivirus/Norovirus events.
- 9) Retire SEROTYPE PATTERN question from GI Illness QP for GI Illness Cluster events.
- 10) Add transmission-specific variables for waterborne and animal contact routes of transmission to enteric cluster events.
- 11) Retire QID "CLUSTER ONGOING" in GI Illness Cluster events.

Immunization/Vaccine Preventable Diseases

- 1) MIIS integration for VPD Measles, Mumps, and Rubella. Vaccination information will appear in disease events these conditions when present in the MIIS.
- 2) Add new questions in the Risk/Exposure QP for Varicella events.
- 3) Updating the Expression of Varicella Workflows to match the new CSTE position statements.
- 4) Updating hierarchy for Varicella Events to include Rash onset date.
- 5) Remove RESPO and ENTRO from Labwork Needs Review Immunization Workflow.
- 6) Adding CASE ID label before MAVEN ID in the letter to providers for CFF.
- 7) Extend Rash Type field Dropdown box.

Zoonotic

1) Create a concern in Rabies - Management events



2) Add Question to "Key Questions for Case Investigation" Wizard in Anaplasmosis and Babesiosis events to capture travel prior to onset.



Viral Hepatitis

- 1) Create a new reference code HEPB MORE LIKELY DIAG.
- 2) Create workflow to update HepB case status from suspect or probable to confirmed based updated case definition.
- 3) Create new variable to capture a more likely diagnosis for clinical symptoms for HBV.
- 4) Update "Acute HBV Identification" workflow.
- 5) Modify existing Probable HBV Events to Confirm workflow to add a date filter.
- 6) Modify existing HCV LAB DNT to include HEPB product code.
- 7) Model changes for Hepatitis C related to potential nosocomial risks.
- 8) Add new questions in HBV events to capture single birth or not

STD

- 1) STD Update the Interview Record Summary Report.
- 2) STD Workflow for Field Epi Transferred or Unassigned Interviews.
- 3) STI Cluster Report for Field Epi and Surveillance.
- 4) Address bug for ethnicity in the Syphilis Risk Factor Tracking Report.
- 5) Address bug in the Syphilis Risk Factor Tracking Report.
- 6) STD Workflow to track cases with indication of neurologic involvement.
- 7) STD Review Syphilis Risk Factor Tracking Report.
- 8) Address bug regarding disease stage buckets in the Syphilis Risk Factor Tracking Report.

- 5) MAVEN to eHARS (document extract) data not being extracted.
- 6) Add additional variables to the MAVEN to eHARS document extract report (HIV).
- 7) Update HIV Cluster report and Acute HIV report.

- 1) TB BRF update TB/LTBI crf date [TB]
- 2) Add new TB question to Risk History Question Package and the RVCT Wizard [TB]
- 3) Update Health Assessment QP & TB classification [RIHP & TB].
- 4) Disease listed has spelling mistake in MAVEN.

ELR / ECR / NMI

- 1) Should we create a new report for failed imports for eCR?
- 2) Modify MIF sent to Maven for ECR to include a userid for better tracking of the data.
- 3) Add userid ECRImport to all Maven environments.
- 4) Managing duplicate Medications from eCR.

- 1) Retire Print Templates from Epi & Refugee Models.
- 2) Request to customize/add additional fields in the user interface for User Profile.
- 3) Language Misspelled for "Telugu" MAVEN Side.
